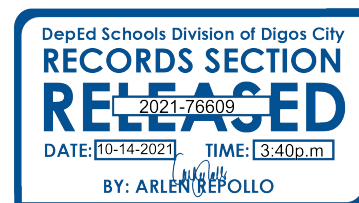

ADVISORY TO DEPED REGIONAL DIRECTORS, SDO SUPERINTENDENTS, AND RO AND SDO FORM MANAGERS ON THE SUBMISSION OF LDM FORMS 4 AND 4P AND OTHER CONCERNS

In reference to the orientation held in July last year, the Learning Delivery Modalities (LDM) Courses shall culminate upon the submission of Form 4 (Pre-implementation Rating) and Form 4P (Practicum Portfolio Rating). Once this is completed, the NEAP-R shall issue the certificates of participation and completion.

An advisory was issued last July 8, 2021 indicating that the deadline for the submission of Forms 4 and 4P was on 27 August 2021. Due to the requests for extension, the deadline was moved at a later date. Unfortunately, there are still regions that have not yet submitted the said forms.

This advisory is to request the submission of the said documents be accomplished on or before 29 November 2021, Monday. Please note that submission of these forms serves as a prerequisite for the attainment of the participants' PD credit units. Moreover, we request NEAP-R to start issuing the certificates of participation and completion once the submission is complete.

Please refer to NEAP Advisory 09-04, s. 2021 issued on September 6, 2021 for the request to indicate the DepEd email addresses of the participants and their gender (male or female) in the Forms 4/4P as part of the awarding of the PD credit units. A separate email was sent last September 8, 2021 to the LDM RO and SDO Form Managers containing the instructions on this. 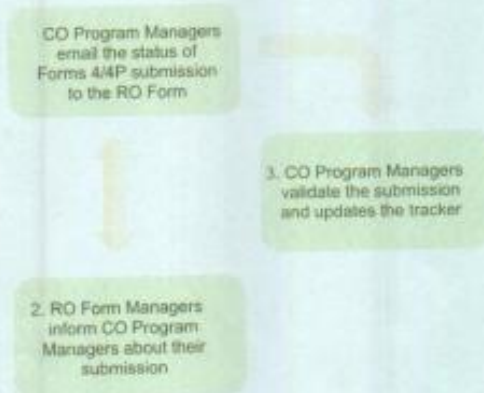
