
GYMNASTICS NATIONAL JUDGES' COURSES

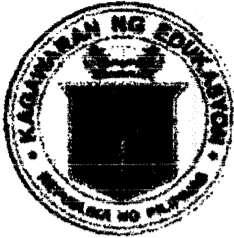
