

**37th PRINCIPALS TRAINING AND DEVELOPMENT PROGRAM AND
NATIONAL BOARD CONFERENCE**

1. The Philippine Elementary School Principals Association (PESPA) will hold the **37th Principals Training and Development Program and National Board Conference (PTD-NBC)** with the theme *PESPAs: The Catalyst of Change for a Better 21st Century Educational Management* from May 4 to 6, 2018 at SMX Convention Center, SM Lanang Premier, J.P. Laurel Ave., Agdao, Davao City, 8000 Davao del Sur.
