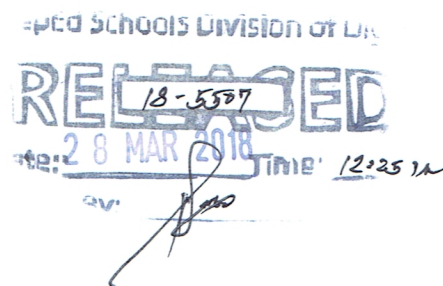

**37th PRINCIPALS TRAINING AND DEVELOPMENT PROGRAM AND NATIONAL BOARD CONFERENCE**

1. The Philippine Elementary School Principals Association (PESPA) will hold the **37th Principals Training and Development Program and National Board Conference (PTD-NBC)** with the theme *PESPA's: The Catalyst of Change for a Better 21st Century Educational Management* from May 4 to 9, 2018 at SMX Convention Center, SM Linares Premier, J.P. Laurel Ave., Alabang, Davao City, 8000 Davao del Sur.

2. The Conference aims to:

- a. identify the School Heads' desired skills or vocal image, his conversational manners, proper posture, and attire for enhanced interpersonal relationship in the work place;
- b. strengthen the 21st century skills of School Heads on the areas of critical thinking and in problem solving;
- c. enhance knowledge of pertinent legal issues on K to 12, rules on appointments and the duties of school heads, and;
