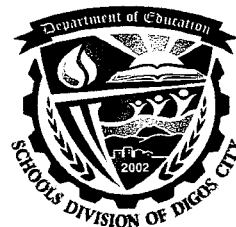

**SUBJECT :** Delivery of VCM to the Polling Places, Final Testing and Sealing, Early Delivery of Election Supplies

Please be informed of the following important dates and activities in connection with the May 9, 2016 National and Local Elections:

1. Delivery of the Vote Counting Machines, Ballot Boxes and Batteries will be done on **May 3, 2016**. BEIs are required to be at the polling places in order to receive the VCM and peripherals;
2. Final Testing and Sealing of the Vote Counting Machine at the respective polling places in all barangays of the city is on **May 5, 2016**;
3. Pursuant to Minute Resolution No. 16-0224 and as approved by ATTY. ALLAN C. KADON, Acting Provincial Election Supervisor, the delivery of Election Supplies and paraphernalia is on **May 8, 2016** from 8:00 A.M.- 5:00 P.M. at the City Treasurer's Office and COMELEC, in accordance with the following schedule:

Candidates and political parties are directed to submit to COMELEC a separate list of watchers assigned per polling place and watchers assigned at the storage areas. Watchers must bring with them their valid IDs and appointment duly signed by the authorized representative. If desired, candidates and parties may also assign watchers at the City Treasurer's Office where the Official Ballots are stored. Watchers without the appointment will not be allowed to guard the storage areas and enter the precincts.
