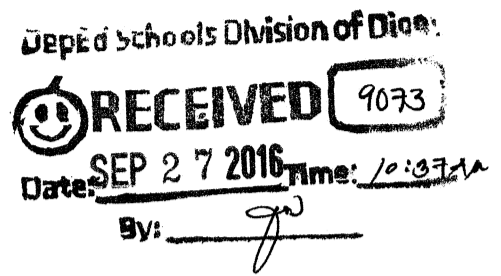

Dear Madam Silva:

Relative to the Career Guidance Advocacy Program (CGAP) which is one of the convergent programs of the Human Development and Poverty Reduction (HRDP) Cluster of the Cabinet and pursuant to DepEd Order No. 25, s. 2013, one goal of the K to 12 Basic Education Program is to produce graduates who are ready for higher education, middle level skills development, and entrepreneurship. It is the aim of the Department of Labor and Employment Relative to our commitment to the convergent program of the Human Development and Poverty Reduction (HDPR) Cabinet Cluster, particularly the **Career Guidance Advocacy Program** (CGAP), to advocate the importance of career guidance to all secondary schools in order to prepare **graduating students** in choosing the right courses that match their interest and the need of the labor market.

One of the challenges found among students is their lack of preparation for life skills. The Filipino Youth will have to increase their competitiveness and competencies so that they will have better chances of getting into productive employment and success in entrepreneurship. The implementation of the Senior High School curriculum is an avenue for our students to acquire the soft skills which the industry is looking for in a prospective employee or entrepreneur. The Career Guidance Program shall be enhanced deeper and will support the curriculum to assist the students acquire these skills. The Guidance Counselors should also be equipped with the necessary knowledge and skills to effectively guide the students.

Thus, pursuant to Rule V, Sec 17 of the RA 10533 the DepEd, in coordination with the DOLE, TESDA, CHED, PRC, NYC, industry associations, professional associations, and other relevant stakeholders, shall pursue programs that will expose students to the world and value of work, and develop the capability of career counselors and advocates to guide the students, a two-day live-in Capability Building Seminar for Guidance Counselors and Career Advocates is organized to capacitate them in guiding the students. The soft skills of students are necessary components of the Senior High School Curriculum.


