



SUBJECT : **CONDUCT OF 2016 DIGOS CITY DIVISION ATHLETIC MEET**

DATE : October 5, 2016

- Pursuant to Section 2 and 3, Article 1 of R.A. 10588 known as Palarong Pambansa Act of 2013, the field is hereby informed that DepEd Digos City Division in coordination with the City Government of Digos, will conduct the Digos City Division Athletic Meet 2016 on **November 11-13, 2016 at Don Mariano Marcos Elementary School Campus and the Digos City National High School grounds.** Participants/athletes from both public and private junior and senior secondary and elementary schools are strongly advised to give their full support and cooperation and comply with the requirements stipulated in Section 22 of the IRR of RA 10588.
- The participants to the 2016 Digos City Athletic Association Meet shall be elementary and secondary athletes from public and private schools. Kinder to Grade 6 athletes shall play in the elementary division and Grade 7 to 12 shall play in the secondary division. Moreover, integrated schools with junior and senior high schools shall compose one (1) team while the DICNHS Stand Alone Senior High School shall compose another team: *Provided*, the cut-off year for secondary is 1999 and for the elementary is 2004.
