**DATE :** November 22, 2016

1. In line with the effort to strengthen the teaching of reading in the Mother Tongue as one of the fundamental features in the K to 12 Curriculum, there will be a three- day Reorientation Seminar-workshop in Teaching Reading in the Mother Tongue to be held on December 7-9, 2016.   - a. Reorient the participants on the framework, teaching/learning standards, pedagogies and competencies in Mother Tongue-base Multilingual Education.
  - b. Capacitate participants on the pedagogies and teaching approaches in teaching reading in the Mother Tongue.

Further, participants are requested to bring Curriculum Guides (CGs) of grades One to Three that will be used during the workshop.
