

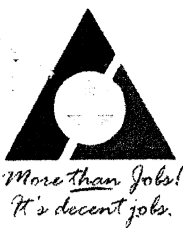

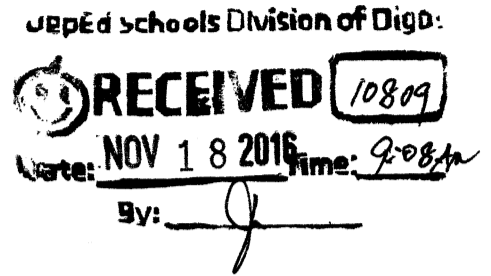

Lastly, we would like to request that all expenses to be incurred during their official trip will be charged to your MOOE subject to the usual accounting and audit rules. As agreed

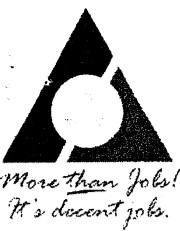
