

Greetings!



SUBJECT : **Selection and Orientation of Inter-regional Training Team for the Basic Training on Indigenous Peoples Education (IPEd) for Selected Schools in the Autonomous Region in Muslim Mindanao (ARMM)**

DATE : **December 12, 2016**

1. This refers to the joint effort of the DepEd-Indigenous Peoples Education Office (IPsEO) and the DepEd Mindanao regions in conducting the Basic Training on Indigenous Peoples Education (IPEd) for Teachers and School Heads for selected schools in ARMM.
2. As you are aware, all regions in Mindanao have been officially engaged in the National IPEd Program, except ARMM. There is ongoing discussion between DepEd-ARMM and IPsEO on how the implementation of the IPEd Program in the said region can be supported, in accordance with its specific legal and institutional framework. As an initial effort and springboard for succeeding engagement, training for 177 schools serving IP learners in ARMM shall be conducted in the first quarter of 2017 (these schools are part of the 2,766 schools nationwide that we have targeted to train by end of 2016; to date, all IPEd-implementing regions have already trained their respective target schools). DepEd Region XII shall host the training activities.
3. For this specific training activity, the pool of facilitators shall be composed of DepEd personnel from various Mindanao regions, particularly those who have served as facilitators/trainers in their respective retooling/basic training on IPEd activities. As a secondary objective, the engagement of IPEd facilitators from the different DepEd field offices of Mindanao in this training initiative is aimed at further enhancing their capability and experience in conducting and managing IPEd training activities, which would hopefully in turn benefit their own capacity building efforts.
4. In line with this, we would like to request DepEd Region XI to identify eight (8) facilitators who will join the inter-regional training team. The following criteria are provided to guide the region in the selection of its facilitators to be nominated for this initiative:

- a) The nominee has been a facilitator in at least two IPEd retooling/training activities (regional or division level) implemented since 2013;
- b) The nominee has attended at least one IPEd Framework formulation session conducted by a division;
- c) While not a requirement, the nominee is preferably a NEAP facilitator of the region.

Once the facilitators have been identified, please send a consolidated list to IPaEO, with advanced copy via email at [ipseo@deped.gov.ph](mailto:ipseo@deped.gov.ph).

(Please note that a facilitator would only serve one (1) batch of the seven (7) training batches, so as not to incur prolonged absence in his/her official station. The training duration is five (5) full days.)

5. To prepare for the actual training activities, we would like to invite the nominated facilitators of the inter-regional training team for a preparatory activity to be held on January 4-6, 2017 at DepEd ECOTECH Center, Cebu. The purpose of this activity is to review the content of the basic IPEd retooling design, agree on tasking and session assignments, discuss considerations specific to the context of indigenous peoples/IPEd in ARMM, and other training management concerns. The exact schedule of training activities shall also be finalized in consultation with the team.

Arrival of participants is on January 3, 2017 (with dinner as the first meal), while departure is on January 7, 2017 (with breakfast as the last meal).

6. Travel expenses of participants to the training preparatory activity to be held at DepEd ECOTECH Center shall be charged to their respective FY 2016 IPEd Regional/Division Program Support Fund, subject to the usual accounting and auditing rules and regulations.
