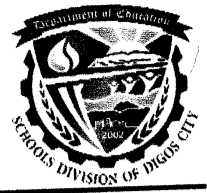



**RESOLUTION GRANTING/AUTHORIZING THE CONDONATION OF PENALTIES
ON REAL PROPERTY TAXES OF DELINQUENT TAXPAYERS IN DIGOS CITY TO
TAKE EFFECT ON JANUARY 1, 2017 UP TO AND UNTIL JANUARY 31, 2017**

WHEREAS, the City Disaster Risk Reduction Management Council has certified that Digos City is one of the cities being hit by the El Niño phenomenon which damaged agricultural crops resulting in big losses to the income of farmers in Digos City for the year 2016;

WHEREAS, foregoing calamity is further bolstered by the fact that most of the barangays of Digos City has been declared under a state of calamity;

WHEREAS, in view hereof, there is a popular clamor for the condonation of penalties on real property taxes of delinquent tax payers in Digos City to help alleviate their above-mentioned losses;

WHEREAS, the august body finds the request just, fair and legal.

WHEREFORE, BE IT:

RESOLVED, as it is hereby resolved, to grant/authorize the condonation of penalties on real property taxes of delinquent taxpayers in Digos City to take effect on January 1, 2017 up to and until January 31, 2017;
