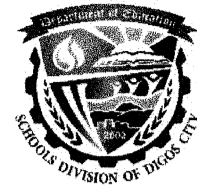


1. In line with the country's commitment to achieve its Education For All (EFA) targets and the Millennium Development Goals (MDGs), and in pursuit of the Basic Education Sector Reform Agenda (BESRA), the DepEd is adopting the National Indigenous Peoples Education Policy Framework, which was prepared in consultation with the representatives from Indigenous Peoples (IP) communities, civil society, and other government agencies.
2. With the advent of the K to 12 as a major educational reform, which features a culture-based education, contextualization is one process whereby schools are given the opportunity to come up with a flexible curriculum that is truly responsive to the Indigenous Peoples context, respects their identities, and promotes the value of their Indigenous Knowledge, skills, and other aspects of their cultural heritage.
3. In view of the above, the concerned DepEd personnel are hereby directed to attend a capacity building seminar, while the IP elders are invited to be with the group for the activity, which will be held on December 19 – 21, 2017 at a venue to be arranged (TBA) later. The objectives of the seminar are as follows:

- a. To gain common understanding of the Ancestral Domain (AD) concept and all other aspects of AD from the perspective of the IP/ICCs;
 - b. To have a unified understanding of the IP Rights especially on the Right to Education;
 - c. To agree on the scope, content, culturally appropriate processes, mechanisms and policies in contextualizing the Curriculum for IP Education; and
 - d. To provide general guidance to DepEd Offices in facilitating the formation of CABs, and that the IP community (rights-holder) through the IP elders and other community representatives understand on how to actualize CAB formulation and gain insights on their roles and functions.
4. Attached is the list of the participants to the activity (Enclosure 1).
5. Accommodation, food, travel, honoraria of the resource persons and other incidental expenses of the participants shall be charged to the IPEd Program Support Fund 2017 (Supplemental), subject to the usual accounting and auditing rules and regulations.
