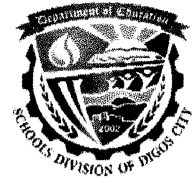

- December 15, 2017 (4<sup>th</sup> Quarter)- Tagum City Division


Anent to this matter, the Division Disaster Risk Reduction Management Coordinator of each division is advised to attend the activity.
