PARTICIPATORY ORTHOGRAPHY ENHANCEMENT WORKSHOP OF REGION XI's IPEd SPELLING GUIDES AND PRIMERS

1. In pursuance to the Indigenous Peoples Education (IPEd) goal to support the appropriateness and responsiveness of the curriculum through development of culturally appropriate learning resources to address the needs of IP learners, this Office through the Curriculum and Learning Management Division (CLMD) shall conduct a Participatory Orthography Enhancement Workshop of Region XI's IPEd Spelling Guides and Primers with the IPEd and Mother Tongue Writers and IP Elders on December 18-22, 2017 at the Sunny Point along Maa Street, Davao City.

- 2. The objectives of this training are to:
 - draft a unified spelling guide per language group, including spelling rules, introduction to basic grammar and dictionary/glossary for community elders' feedback;
 - 2. identify the first language of IP learners per language group of each division;
 - 3. identify the status of each language group being represented; and
 - 4. identify and initially test all of primer's key words.
