It is in this premise that the Curriculum and Learning Management Division (CLMD) will conduct the Regional Conference of Division IP Elders (Top 3) on the Formation of Consultative and Advisory Bodies (CAB) on Indigenous Peoples Education (IPEd) Program on December 28, 2017 at Sunny Point Hotel and restaurant, along Maa Road, Davao City.



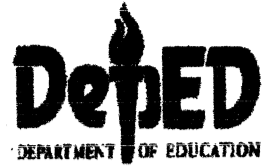
