AND SUBMISSION OF SCHOOL DRRM ACTION PLAN 2017**

DATE : March 1, 2017

1. This pertains to DepEd Order No. 20, s. 2011 entitled "Creation of Disaster Risk Reduction and Management Office (DRRMO)" and Division Memorandum No. 107 entitled "Capacity Building Seminar for Division and Schools Disaster Action Teams, this division reiterates the mandate on the establishment of mechanisms that prepare, guarantee protection and increase resiliency of the Department of Education constituents in the face of disaster.
2. In line with the observance of the Fire Prevention Month 2017, the Official Theme for this year is "**Buhay at Ari-arian ay Pahalagahan, Ibayong Pag-iingat sa Sunog ay sa Sariling Pamamahay Simulan**". This calls for safety awareness campaigns and active involvement and cooperation of the public in the campaign of fire safety. The following are the suggested activities for the schools to undertake:
 - a. Hanging of Tarpaulin in support to the Advocacy Campaign on Fire Prevention;
 - b. Lesson Integration on Fire Safety;
 - c. Fire Safety Campaign/Symposium; and
 - d. Earthquake/Fire Drills.
3. Relative to the Capacity Building Seminar held on February 23-24, 2017, one of the agreements is that the School DRRM Action Plan shall have been crafted and shall have been submitted to the Division Office not later than **March 10, 2017 Friday**.
