

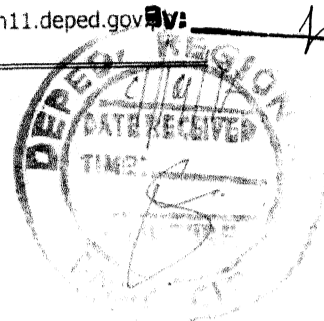

We would like to request for an Authorization Letter to Deliver from your good office stating the following:

- A.) That we, N. R. Eustaquio Enterprises Inc., is being mandated thru a contract to deliver TVL Specialization Tools & Equipment for Housekeeping NC II and that we be given due accommodation and priority to prevent further delay of our delivery as we only have 21 days left to accomplish our delivery.
