#### I - Declaration of Purpose

Search for Outstanding Constituents of Davao del Sur bestows honour to the virtues of teaching by providing role models who has contributed to the development in the field of Education of the province of Davao del Sur with exemplary competence and dedication. The awardee best serves as a model of excellence and an inspiration to the residents of Davao Del Sur.

This award has the intention of providing the province with the examples of excellence for other educators to emulate and to consequently improve the quality of education in the province.

## II – General Requirements

- 1. Open to Filipinos born in Davao del Sur or have been residents in Davao del Sur for at least 10 years. The nominee must accept the nomination. Previous nominees can be nominated again. However, previous awardees will no longer be considered unless there is a different reason for another recognition based on the guidelines;
- 2. Actively teaching in private or public primary, elementary or secondary schools:
- 3. Has been teaching (SPED, ALS, FORMAL Ed.) for at least ten (10) years;
- 4. Substantial contribution to the growth and development of education in the province of Davao del Sur is evident;
- 5. Has employed creativity, innovation, and resourcefulness in teaching;
- 6. Exemplary services rendered to the school and community in the field of education;
- 7. Work related accomplishments must merit regional, national or international recognition placing the province in the map;
- 8. Must be a law-abiding citizen, of good moral character and integrity; and has a good reputation in the community.

#### III - Criteria for Evaluation

| Teaching History                        | 30% |

#### **IV - Selection Process**

#### Nomination:

Who can nominate?
Partner Organization, School Associations, Religious Organizations,
Department of Education, and School Heads, Students, and Teachers
can nominate qualified teachers.

Nomination forms can be obtained from Provincial/Municipal/City Administrator's Office and City and Province Schools Division Office.

#### 1. Submission of Nominations

Nominations must be submitted to: DepEd City Schools Division Office and DepEd Provincial Schools Division Office on or before **June 09, 2017**.

2. Evaluation of Nominations by The Screening Committee

The screening committee evaluates the nominations forms based on the criteria and determines the short-listed nominees.

- 3. Validation and Interview/ Establishment of Profile/ Background Check
  - Short-listed nominees are contacted and an interview is scheduled.
  - The interview validates the qualification of the nominee and establishes his/her profile.
  - Based on the results of the interview and background check, the Screening Committee selects the top three (3) finalists.

#### 4. Selection of Winners

• From the top three (3) finalists per category (Formal Education, ALS, SPED), the Selection Committee selects the winner of the Award in the field of Education.
