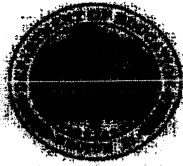

Said privileges are in accordance with DepEd Order No. 53, s. 2003 on *Updated Guidelines on Grant of Vacation Service Credits to Teachers* and Civil Service Circular No. 2, s. 2004 on *Non-Monetary Remuneration for Overtime Service Rendered*.
