- 1. In view of the yearly observance of the National IPs Month Celebration every October, a Pre-Planning Meeting for the Regional and Division Panaghiusa Festival 2017 shall be held on September 15, 2017, at the New Division Office Conference Room, from 1:00pm to 5:00pm.
- 2. For those classroom teachers involved, the "No-Disruption-of-Classes Policy" as stipulated in DepEd Order No. 9, s.2005 entitled "Instituting Measures to Increase Engaged Time-on -Task and Ensuring Compliance Therewith" shall be strictly adhered to. In their instance, a shortened period is to be employed such that students' contact time for classroom instruction is not shortchanged.
- 3. Similarly, school heads shall leave OICs to take charge of the school operations while they are out for the meeting.
- 4. Duly accomplished Authority to Travel shall be prepared one day prior to attendance in the said activity.
- 5. Travel, snacks and other incidental expenses are chargeable to IPEd-PSF 2017(Division downloaded), subject to the usual accounting and auditing rules and regulations.
