The Department of Education (DepEd) under the new leadership has instituted various reforms to further improve the delivery of education services to our learners. New policies were issued and other important policies will be issued within the year. Planning Service and its counterparts across governance levels play a big role in the development, implementation and monitoring of these policies. It is important that planning and research specialists of DepEd are fully aware of the reforms and how they can effectively discharge their roles and responsibilities and making sure that plans and policies are well understood, properly implemented and regularly monitored. Planning service is also managing and leading the DepEd's information systems, research initiatives, policy development and planning and budgeting exercise which are crucial in the overall DepEd operations.

To be abreast on the new developments, the Planning Service will organize the **2<sup>nd</sup> National Planning Conference on October 10-12, 2017** (exclusive of travel time) at Iloilo City (exact venue will be announced later in separate issuance). Specifically, the conference will allow participants to understand, articulate or apply the following:

- DepEd's Strategic Direction, 2017-2022 and its relationships with the Ambisyon Natin 2040 and Sustainable Development Goal 4 2030;
- 2. DepEd's strategic, medium term and operational planning process;
- 3. Research and Policy Development Process;
- 4. Monitoring and Evaluation Framework, and
- 5. New features of LIS and EBEIS.

The indicative program of activities is attached as Annex 1 and the expected participants are: (1) **Central Office** - All personnel of the Planning Service and selected invited guests and participants; (2) **Regional Office** - PPRD Chief, Regional Planning Officers, and QAD Chief; and, (3) **Schools Division Office** - Senior Educational Program Specialist (SEPS) for Planning and Research, and Division Planning Officers.

To ensure smooth implementation of the activity, all participants are hereby requested to observe the following:

- 1. Travelling expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations;
- 2. Confirm your attendance through this link: http://bit.ly/DepEd\_2nd\_National\_Planning\_Conf on or before September 30, 2017. Failure to register may affect your accommodation;
- 3. The dress code for the conference is smart casual while formal dress during the Awards Night;
- 4. Accommodation will start at 2:00 PM on October 9, 2017 and the first meal to be served will be dinner on the same date. Check-out is until 12:00NN of October 12, 2017 and last meal is dinner on the same date. The Front Desk Officer will book the participants as they arrive to the Hotel. No switching of room shall be requested for smooth hotel registration and accommodation;
- 5. DepEd-Planning Service through Schools Division Office of Iloilo will pay the hotel for the cost of board and lodging only for the duration of the conference. All other personal incidence expenses (e.g. late check out/early check in, telephone, fax, mini-bar, laundry, room service, etc.) will be charged to the participant's account and should be paid directly to the hotel before departure;
- Register and obtain meeting badges and materials at the registration counter which will be located outside the conference venue from 5:00PM to 7:00PM on October 9, 2017, and
- 7. Be at the workshop venue before 8:00AM on October 10, 2017.
