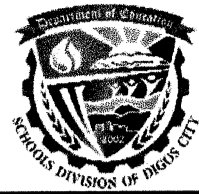

**RENEWAL OF PROFESSIONAL REGULATORY COMMISSION'S (PRC)
 PROFESSIONAL IDENTIFICATION CARD (PIC) EXPIRING
 NOVEMBER 2017 – 30 NOVEMBER 2018
 FOR PROFESSIONAL TEACHERS**

To: Elementary and Secondary/SHS Professional Teachers

1. This has reference to Republic Act No. 10912, S. 2017, otherwise known as the "**Continuing Professional Development (CPD) Act of 2016**" which requires CPD as mandatory requirement for the renewal of the PIC. The CPD Act became a law on July 21, 2016 and took effect on August 16, 2016, while the implementation of R.A. No. 10912 started on March 15, 2017 upon the effectivity its Implementing Rules and Regulations (IRR).
2. For **Professional Teachers**, below is the transitory period for the compliance of the required credit units (CU) pursuant to Resolution No. 11, S.2017 of the Professional Regulatory Board of Professional Teachers:

| Year of Renewal | Required No. of CUs |
|------------------------------|---------------------|
| Before December 01, 2017 | 0 |
| December 01, 2017 | 15 |
| January 2018 – December 2018 | 30 |
| January 2019 onwards | 45 |

3. PRC also allows the renewal of PICs within one (1) year prior their expiration dates.
4. Aside from those whose PICs are due for renewal, those who have their PICs expiring from the time of receipt of this memo to 30 November 2018, are thereby encouraged to renew their PICs **before November 30, 2017**, to avail of the "**0 number of CUs required**".
5. Application for renewal is available online. Go to www.prc.gov.ph and click "**ID Renewal**". (See attachment)
6. Since the actual renewal of IDs is done on official time, a printed copy of the confirmed schedule of appointment at the PRC office is a requirement for travel orders to be signed.
