7. Any participants who fail to comply with the requirements and qualifications specific to each category shall be disqualified.
8. Coaches of Arabic Language Spelling and Islamic Values Education Quiz Bee are required to submit five (5) questions in every category (Easy, Average, Difficult and Clincher).
9. Asatidz and concerned teachers are expected to make necessary arrangement such that classes are taken care of during their absence.
10. Traveling expenses and food allowance which includes the meals and snacks shall be charged to Madrasah Education Program (MEP) Funds - Program Support Fund (PSF) 2017 while other incidental expenses incurred during the attendance to the said activity are chargeable against school MOOE/local funds subject to the usual accounting and auditing rules and regulations.
