Attached is the project proposal, matrix of activities and the Board Resolution of the association.

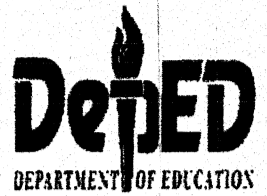

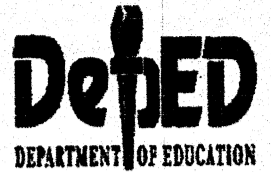

- d. Committees/TWG (shall be discussed during the next EXECOM Meeting)


WHEREFORE, upon deliberation and on motion of Armando Olmedo, duly seconded by Datu Roger Manapol it was:
