A maximum amount of Four Thousand Eight Hundred Fifty Pesos (Php 4,850.00) will be given to each participant to cover the food, travel allowance and other incidental expenses while undergoing Work Immersion, chargeable against the 2017 Funds for the Implementation of the Redesigned Technical-Vocational High School Program (2016 Continuing Appropriation), all subject to the usual government accounting rules and auditing procedures. The reimbursement of travel expenses of the participants will be through List of Due and Demandable Accounts Payable-Advice to Debit Account (LDDAP-ADA) subject to the submission of complete travel documents.
- 5. Participants are entitled to Service Credit/Compensatory Over Time Credit (COC) for Immersion schedule that falls during Saturdays, Sundays, and Holidays as per CSC-DBM Joint Circular Memorandum No. 2, s.2004 and DepED Order No. 53, s.2003.
- 6. Immediate dissemination of this Memorandum is desired.
