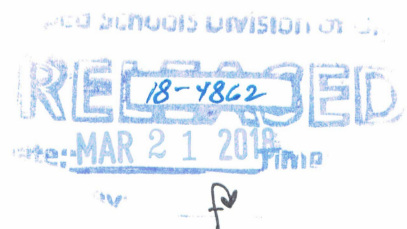


SUBJECT : **SPECIAL PROVISION FOR THE SCHOOL HEADS AND
