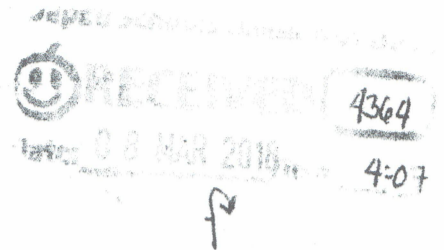


Food and Hotel Accommodation shall be charged against DOH-STHCP Funds while travelling expenses and per diem of participants shall be charged against sending agency.
