- 2. This designation is an addition to your functions as stipulated in Division Advisory No. 09 s. 2016 dated February 9, 2016.
- 3. Services rendered during Saturdays and Sundays or on February 25, 2016 which was declared as a non-working holiday are entitled to earn a one-day Compensatory Overtime Credit (COC) per eight-hour work day with reference to the following issuances:
 - 2.1. Civil Service Circular, Art 87 of Labor Code and RA 4670 of work performed beyond an employee's regular duty hours of 8 hours in a day;
 - 2.2. Administrative Order No. 103 (Directing the Continued Adoption of Austerity Measures in the Government) issued in 2004 by the President of the Philippines that affording non-monetary compensation of services rendered which are beneficial to the government (employer) and the (employees) [both parties].
