- 1. In pursuance to DepEd Order No. 9, s. 2016, dated February 18, 2016, DepEd Order No. 7, s. 2015 entitled *Hiring Guidelines for Teacher 1 Positions Effective School Year (SY) 2015-2016* is reinforced as the primary hiring policy to be used in the evaluation and selection of teachers for the kindergarten, elementary, and junior high levels from hereon until further notice.
- 2. Further, as stipulated in the said Order, DepEd Order No. 22, s. 2015 entitled *Hiring Guidelines for the Remaining Teaching Positions Effective SY 2015-2016* shall be used in the event that the schools division office still has available teaching positions after having implemented DepEd Order No. 7, s. 2015.
- 3. Guided with DepEd Order No. 9, s. 2016, the timeline below shall be observed, thus, Division Advisory No. 014, s. 2016 dated February 16, 2016 is hereby repealed.
