




Pursuant to Unnumbered Memorandum dated 29 January 2016 entitled "Promoting Adoption Consciousness", this Offices announces the **Regional Level Oratorical Contest** on **April 26, 2016 (Tuesday)** at **Waling-Waling Hall, DepEd Regional Office, F. Torres St., Davao City at 9:00 in the morning.**

One contestant each Division shall compete during the regional level. It is expected that each Division shall submit the name of the contestant who is from Grades 7 to 9 during the School Year 2015-2016 on/or before April 22, 2016 (Friday).

Attached is the general guidelines for the conduct of the Regional Level Oratorical Contest.

Travel and other expenses of the contestants, teacher-coaches and division education program supervisors relative to this activity shall be charged to local funds subject to the usual accounting and auditing rules and regulations.

Regional Level Oratorical Contest Guidelines
April 26, 2016 (Tuesday)

General Rules: Subject to such changes as may be determined appropriate, the following general rules shall apply:

- The contest is open to all Grade 7-9 students enrolled during SY 2015-2016 from public and private secondary schools in the Division;
- There shall be only one contestant per division, male or female;
- The Oratorical piece must be in Filipino, original and never been published expounding on the theme : "Legal na Ampon Ako: Anak na Totoo";
- The Oration SHOULD NOT, in whole or in part, expressly and impliedly offend any race, religious freedom, against the laws of environment, honor and dignity, and against the moral standards of the Filipinos;
- The concerned agencies have the right to publish the selected contest pieces and the right to determine other matters not included under the contest rules;
- During the Regional level Contest, all contestants must submit to the Education Support Services Division (ESSD) five (5) copies of their Oratorical piece written in long bond paper, double spaced, Times New Romans and font size is 12 upon their arrival to the contest venue;
- During the competition, the contestants shall wear the appropriate attire:
Male- Barong Tagalog Female – simple Filipiniana dress
- There will be three (3) winners. First, second and third placers. The winners will be receiving plaques and the first place will compete in the Grand National Finals in June, 2016. In case of a tie, the judges shall unanimously decide on who will be declared as the winner. Proper replacement shall be applicable in case the representative could not attend the contest, but concerned parties shall notify the ESSD at least a day before the contest proper;
- The decision of the Board of Judges shall be final and non-appealable/irrevocable;
- Travel and other incidental expenses and the board and lodging of the participants, teacher-coaches and division education program supervisors during the regional level competition shall be charged to local funds or maybe sourced from non-government organizations, municipal/city funds and civic spirited clubs and organizations subject to the usual accounting and auditing rules and regulations; and,
- The criteria for judging are as follows:

1. Content (sincerity, originality and relevance to the theme)	- 50%
2. Delivery (posture, gesture, eye contact, facial expression, Pronunciation, volume and mastery)	- 40%
3. Persuasion and Stage Presence	- 10%
