

1. Please be advised that a Gender Analysis Training/Workshop/Write Shop on Gender And Development (GAD) Program in DepEd Region XI, will be conducted on September 19-20, 2016, at RELC - NEAP XI, Quirino Avenue, Davao City.

## 2. The agenda will cover the following concerns:

 Inability of mainstreaming GAD concepts in education which requires knowledge on gender analysis.

 Preparation of education Programs, Activities and Projects (PAPs) which can be attributed to Gender And Development (GAD).

 Poor utilization of sex-disaggregated data in mandated GAD responsive plans, budget and reports.

Awareness to the different cultures, traditions, beliefs of Indigenous Peoples (II's) and other marginalized groups relative to Gender And Development programs and services.

3. Attendance of identified personnel to the said activity is required and should be given priority.

Each Schools Division Superintendent is advised to select three (3) School IP teachers: one (1) School Head of an Implementing Unit) per schools division; and the Division GAD Focal Person, as participants.
