National Achievement Test (NAT) for Grade 10	March 2, 2017
Language Assessment for Primary Grade (LAPG) renamed as Early Language, Literacy and Numeracy Assessment (ELLNA) (DO 55, s. 2016)	March 7, 2017
National Achievement Test for Grade 6	March 9, 2017
