

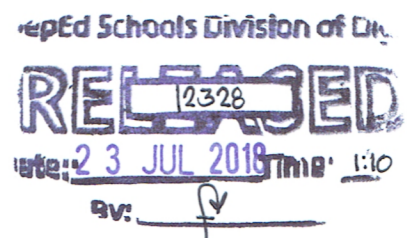

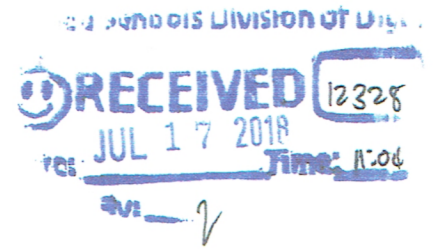

Philippine Red Cross Davao del Sur Chapter will be having the second round of the Performance, Quality and Accountability (PQA) capacity and compliance assessment.


There will be a team of assessors assigned by the PRC-National Headquarters to facilitate the assessment of the chapter.
