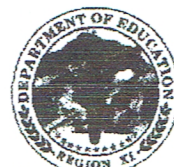



Travelling and incidental expenses of the participants is chargeable against local funds subject to the usual accounting and auditing rules and regulations.


