5. For immediate dissemination and strict compliance.

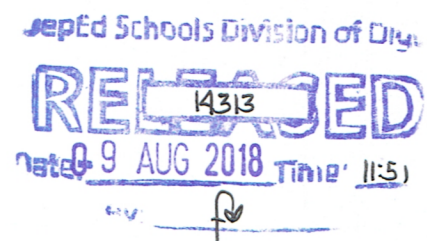
