- 1. 'Project HIMSOG' is the umbrella program of this Division that aims to strengthen the Health and Nutrition Programs of DepED in order to provide a much effective and yet attainable and realistic goals in providing health services to the learners. School - Based Feeding Program is one major program under 'Project HIMSOG' that served hot meals to all identified Severely Wasted and Wasted learners for 120 days with an allocation of Php 18.00 per learner.
- 2. The field is hereby informed that there will be a Performance Implementation Review on the School-Based Feeding Program implementation for calendar year 2018 on DECEMBER 14, 2018 at 8:00 in the morning with venue to be announced.
- 3. The objectives of the activity are the following:
 - to evaluate school level implementation of the program;

 - to map out strategies to support the feeding gaps from January to May 2019;
 - to present future plans for SY 2019-2020;
 - showcase of 5 SBFP schools identified during the Regional Evaluation;
 - showcase of all regional winners on SBFP best practices and GPP winners.
- 4. It is requested that the 5 schools monitored by the Region XI Health and Nutrition Personnel last October 16, 2018 will present a 5 minute video showing school's best practices in the implementation of the program.
