### 119th ANNIVERSARY OF THE PHILIPPINE CIVIL SERVICE

## To: DIVISION OF DIGOS CITY NON-TEACHING AND TEACHING PERSONNEL

- 1. Pursuant to the unnumbered Memorandum dated July 9, 2019 of Evelyn R. Fetalvero, CESO V, Assistant Regional Director, Officer-In-Charge of the Office of the Regional Director, Department of Education, Regional Office XI, Davao City, you are hereby enjoined to participate in the celebration of the 119<sup>th</sup> Anniversary of the Philippine Civil Service in September 2019 with the theme: "Civil Service at 119: Upholding Integrity and Building a High Trust Society" like the display of Anniversary Banner in the Division Office and Schools, among others. The design of the banner was already upload in the messenger of the DepEd Digos City Administrator.
- 2. The Schools Division Office and School personnel are encouraged to join the activities provided by the Civil Service Commission Regional Office XI, Davao City. However, you may conduct other activities that will promote this year's theme, such as, but not limited to the following: Family Day Sport Fests, Clean-Up Day, Retiree's Homecoming, Outreach Program, People's Day, Recognition/Awarding Rites, and other similar activities that will give meaning to this year's celebration theme.
- 3. In connection with Sports Fests activities, the Schools Division Office shall be stating tournament for basketball men, volleyball women and badminton doubles (men and women). Mr. Felzev C. Sayson (basketball), Mr. Christian Granada and Ma. Hilda Lourdes N. Maung (volleyball women), and Mr. Edward Paller and Mary Liezel B. Jumawan (Badminton) shall be the tournament managers. Tournament Mangers shall have the autonomy on the event they are assigned to which includes receiving of entries, searching for venues, scheduling of games and designating referees/umpires during the game. The team composition shall be per district with one entry from the Digos City National High School and the Schools Division Office. The elimination games shall be played every after office hours except for the championship games which shall be during the culmination day on <a href="September 30, 2019">September 30, 2019</a>.
