



The Department of Education National Executive Commission will hold its **13th National Congress and Symposium on the Dynamic Role of the DepEd-NEC Towards the Realization of the Reform Agenda of Secretary Leonor Mansueto** from **June 10-14, 2019** (exclusive of travel time) at the **Greenbelt Convention Center, Alabang, Muntinlupa City, Metro Manila**.

2. The congress aims to

- a. provide the participants with an in-depth understanding of the **Basic Education Agenda and the 10-Point Basic Education Agenda**
- b. develop and propose appropriate responses to the **DepEd non-academic rank and file** and **10-Point Basic Education Agenda**
- c. raise awareness on the **critical role of the DepEd-NEC**
- d. strengthen DepEd-NEC's **committees, programs and projects** as a **key factor in the delivery of quality and high performance**

3. Participants to this congress are **DepEd-NEC members at the regional, schools divisions and non-academic rank and file employees of DepEd-NEC at the central, regional, division, and school levels; DepEd-NEC officers/assistants/heads, attorneys, budget and financial officers, education program specialists, research and development officers, human resource management officers, information and security officers, medical officers/nurses, project development officers, special investigation officers, statisticians, and other non-teaching personnel. 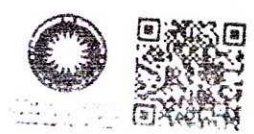
