GRANTING OF ALLOWABLE PROVISIONS FOR POSTPAID LINES AND PREPAID LOAD TO HEADS OF SECTIONS AND OTHER SCHOOLS DIVISION OFFICE PERSONNEL

TO: OIC-ASSISTANT SCHOOLS DIVISION SUPERINTENDENT DIVISION CHIEFS HEADS OF SECTIONS OTHER SCHOOLS DIVISION OFFICE PERSONNEL

- Pursuant to the Department of Education Order No. 017, s. 2019, known as "Guidelines on the Provision and Use of Official Mobile Phones, Postpaid Lines and Prepaid Loads Provision and Use of Mobile Postpaid Lines and Prepaid Loads for the Department of Education", granting of communication allowance/s shall be provided to SDO personnel observing the Department Order.
- 2. Section 4, Number 1 of the said DepEd Order provides that "this provision shall not be treated as allowance, but as an expense subject to reimbursement or liquidation procedure requiring submission of the corresponding billing statement and/or official receipts." Further, Number 7 also provides that "charges from postpaid plan in excess of the monthly ceiling of authorized provision shall be paid for the personnel concerned."
- 3. In view thereof, the attached List of Personnel are the eligible recipient of the communication allowance as authorized by the Schools Division Superintendent. Further, the communication allowance of the DRRM Coordinator and Planning and Research Section personnel shall be chargeable to their respective programs.
- 4. This memorandum shall take effect for the month of December 2019 and onwards.
