Workshop on Indigenization of Lesson Plans and Field Tests of ILPs for use by Kinder, Grade I, II and III

- 1. Pursuant to DepEd Order No. 62, s.2011 entitled Adopting the National Indigenous Peoples Education (IPEd) Policy framework and DepEd Order No. 43, s.2013 entitled Implementing Rules and Regulations of Republic act No.10533 Otherwise known as the Enhanced Basic Education act of 2013, the Department of Education (DepEd) is adopting the Indigenous Peoples Education Curriculum Framework. Recognizing the right of IPs to basic education that is culturally rooted and responsive, the IPEd Curriculum Framework seeks to provide guidance to schools and other education programs, both public and private, as they engage with ICCs in localizing, indigenizing, and enhancing the K to 12 Curriculum based on their respective educational and social contexts.
- 2. Based on the above premise, Digos City Division will be conducting a two-day live-in workshop on February 21-22, 2020 with the following objectives:
 - a. To enhance the national curriculum in relation to the community life cycle while recognizing appropriate scope and sequence of competencies;
 - b. To inter-relate the competencies in enhancing the curriculum and teaching-learning process;
 - c. To recognize the community as the wider space, environment, and resource of learning; and;
 - d. To incorporate the community's narratives of local and national history and contemporary issues and concerns confronted by the IPs (Thus, the participation of the IP elders, and other culture-bearers during the training)
- Participants are expected to be at Megan's Function Hall, Lim-Bataan Streets, Digos City at 5:00 p.m. of February 20, 2020 for the opening program. (See enclosure for list of participants)
- Meals and accommodation shall be charged against IPEd PSF 2019 subject to the usual accounting and auditing rules and regulations.


