



Peace and a blessed New Year from all of us at ERASTO FILMS!

Just last November, we were able to secure rights to distribute "Verdict" an internationally-acclaimed film and the Philippines' entry to the Oscars, which almost perfectly depicts the grueling journey of a wife's legal battle against her abusive husband.

Launched in time for the Campaign to End Violence Against Women (VAW) last year, we were able to screen in 20 government agencies with an inspiring discussion crafted from the sharing of our campaign head, Ann Angala, on how she survived and finally freed herself from domestic violence after 18 years and five children (please see attached article).



ERASTO FILMS is a company whose mission is to make advocacy cinema accessible to everyone.

We believe "Verdict" is the perfect follow-up to "Boses" which we produced and have been distributing locally and worldwide for 11 years now not only in film festivals but in thousands of government agencies, schools, LGU's, NGO's, and communities with a discussion on Violence Against Women and Children (VAWC) — an issue that is cultural and is deeply rooted in childhood.

Based on real events, "Verdict" (2019) takes us to the "lion's den", so gripping, one cannot take one's eyes off the screen. Written and directed by Raymund Ribay Gutierrez, it stars Max Eigenmann. Best Actress at Asia Pacific Screen Awards and the late Kristoffer King, Best Performance for Final Role at the Singapore International Film Festival Silver Screen Awards. Produced by globally-recognized director Brillante Mendoza's Center Stage Productions, "Verdict" is recommended by the Philippine Commission on Women (PCW) as a Gender and Development activity (GAD) (please see attached).

We would like to offer your office an interactive women-centric film seminar that takes off from the screening of the film to a practical discussion on the laws on domestic violence vis-a-vis what is happening in reality, to contextualize the gap between statistics of abuse in one out of four women, to a mere 11,000 actual filing of cases. The discussion is meant to counter the fear and lack of support for the reporting and filing of cases to equipping women on how to see the red flags in relationships as a preventive measure to win VAW legal cases.

We believe this is a pressing cultural issue as it is a legal issue and that to achieve a VAW-Free Philippines, we must first be able to show perspectives and engage in dialogues in order to change mindsets for the better and thus, gain real community support for rightful action and true emancipation.







18-DAY CAMPAIGN TO END VAW RECOMMENDED FILMS FOR 2019

The Philippine Commission on Women (PCW) recognizes film as a powerful medium in raising awareness on Violence Against Women (VAW) and inspiring action against it. It also serves as catalyst for discourses/dialogues on VAW, highlighting the experiences and plight of the VAW-victim survivors. Thus, the PCW recommends the following films that tackle the issue of VAW for film showing by agencies, partners, and stakeholders as part of their activities during the 18-Day Campaign to End VAW from November 25 to December 12, 2019.


As part of the selection process, producers and distributors accomplished a form setting out the context of the film in relation to VAW. All films were reviewed by the PCW, to ensure that these abide with the criteria and that the production house/company understands the terms and conditions for the screening.

Since the film showing activity should complement the overall advocacy on VAW, organizers and film producers are strongly advised to process insights and reflections conveyed by the film right after the film showing. Copyright to the recommended films remain with the producers and they remain independent from the PCW.

1. Verdict (R13 / CEB Graded A)

Joy and her six-year-old daughter Angel live in Manila, with her husband, Dante, a small-time criminal. As so often in the past, Dante comes home drunk at night and beats Joy brutally. This time, he also hurts Angel. Joy grabs her daughter and flees to the local police post to finally get him sent to jail. Justice, Joy learns, takes time at best and is impossible to get at worst.
