

On February 12, University President Fr. Joel E. Tabora, SJ, released Memorandum No. 2020-010 (Precaution Against the COVID-19). The memorandum is in accordance with the Department of Health's advisory to "avoid attending, participating in, and organizing events that draw a huge number of attendees."

With this, we would like to ask your good office to disseminate the cancellation of the event, especially to the schools that have been invited.


Your dissemination of the cancellation would greatly help in securing the health and safety of the invited Junior High School and Senior High School students amidst the threat of the Coronavirus.

We deeply apologize for the abrupt cancellation.


