Date : February 10, 2020

In support to the strategic objectives of DepEd Regional Office XI for management of provision of learning resources to schools, this Office advises the Schools Division Offices (SDOs) to set into motion the Development of Detailed Lesson Plans (DLPs) from Daily Lesson Logs (DLLs) in English Language Arts (ELA) Curriculum submitted by the Division of Davao del Norte from February 24, 2020 to March 6, 2020. This activity involves the following participants:

1. Division EPS in English
2. Division LR Manager
3. Division Development Team (to be identified by the EPS Incharge of English and LR Manager)
4. Quality Assurance Team (to be identified by the LR Manager from the pool of Learning Resource Evaluators)
5. Division Writers

The terms of reference in the execution of the above deliverables are based on the agreements during the conduct of Skills Enhancement on Quality Assurance of Learning Resources for Regional and Division Education Program Supervisors on January 27-30 at the Ritz Hotel:

1. The development of DLPs from DLLs shall be according to assigned grade level per division from first to fourth quarters:
 - a. Grade 1 – Davao de Oro
 - b. Grade 2 – Davao City
 - c. Grade 3 – Davao del Sur
 - d. Grade 4 – Davao Occidental
 - e. Grade 5 – Davao Oriental
 - f. Grade 6 – Digos City
 - g. Grade 7 – Panabo City
 - h. Grade 8 – Mati City
 - i. Grade 9 – IGACOS
 - j. Grade 10 – Tagum City
2. The alignment of learning competencies per domain shall be based on the curriculum guide for English;


3. The application of varied pedagogical strategies like Early Language, Literacy and Numeracy (ELLN), Developing Appropriate Practices (DAP), Pedagogical Retooling in Mathematics, Language and Science (PRIMALS), Explicit Teaching (ET) and Differentiated Instruction (DI) shall be embedded in the DLP;
4. The services of writers who developed the DLL in ELA from the Division of Davao del Norte and all Schools Division Offices (SDOs) are encouraged to involve any of the writers from the Division of Davao del Norte to assist and shed light in the crafting of the DLP. Such may be requested and arranged through the Schools Division Superintendent to forestall disruption of classes; and
5. The developed DLPs shall pass through quality assurance, field testing, revision and finalization.

Travel, meals and other incidental expenses of participants relative to the development of the DLPs shall be charged against Division MOOE/Local Funds, all subject to the usual accounting and auditing rules and regulations.
