It is a nationwide government undertaking with the primary objective of providing government executives, policy makers and planners with the population and housing data on which to base their social and economic development plans, policies and programs.
- Anent to this, all Public Elementary School Heads are hereby directed to recommend teachers to serve as Enumerators (ENs) for the said activity based on the attached number of teachers per school. Recommended teachers are required to submit the following, to wit;
 - Personal Data Sheet
 - Medical Certificate Fit for Fieldwork
 - Letter of Consent (from the School Head)
 - Certificate of Non-Involvement to School-Related work, task and assignments such as Brigada Eskwela until the end of census work but not beyond 06 June 2020 shall be issued by the School Heads for teachers, while for School Heads, PSDS and EPS the certification shall be signed by the SDS.
- School heads must consolidate the recommended personnel (Enumerators) together
 with the attachments. For Barangay Zone II where no public elementary school is
 located, the applicants shall submit directly to the Schools Division Office with the letter
 of intent together with the other documents listed above.
- 4. Moreover, Census Area Supervisor (CAS) will also be created which shall compose of PSDS or EPS and Team Supervisors (TS) Master Teachers, Head Teachers and Principals they are also required to submit to this Office the documents listed above. All submitted documents are subject for review and evaluation by the Philippine Statistics Authority (PSA) personnel.
- 5. Deadline of the submission is on or before March 13, 2020 not later than 12:00 in the afternoon.
- Information dissemination shall be included during homeroom PTA meetings and to students as to the conduct of 2020 Census within the Month of May 2020.


