- 3. The Task Force is mandated to undertake the following:
 - a. Coordinate with the City Health Office for preventive measures, information sharing, and establishment of referral system for persons exhibiting respiratory infection and/or exposure to a Person Under Investigation (PUI) and Person Under Monitoring (PUM).
 - b. Disseminate issuances from the City Government of Digos to all offices and schools.
 - c. Orient all DepEd personnel and learners on the precautionary health measures to prevent the spread of COVID-19;
 - d. Conduct meetings or conferences;
 - e. Ensure availability of health or disinfecting supplies in all offices;
 - f. Monitor closely the health status of the school populace and offices;
 - g. Establish localized policy or protocol relative to COVID-19;
 - h. Distribute COVID-19 Information, Education and Communication (IEC) materials to offices and schools;
 - i. Establish local hotline numbers for the schools for queries and information purposes; and
 - j. Provide updates on COVID-19 to all DepEd Personnel and learners based from DepEd Situational Reports, WHO and DOH Advisories and LGU issuances.
- 4. The Focal Person of the COVID-19 Task Force shall be Mr. Reyzen O. Monserate, PDO II/Division DRRM Coordinator.
