- 1) Pursuant to the **Implementation of the Learning Delivery Modalities (LDM) 1 Course for Division and School Leaders under the Basic Education Learning Continuity Plan (BE-LCP)** which emphasizes on the continuation of classroom instruction despite the pandemic that sweeps the country and the world today, all Public Schools District Supervisors (PSDS), Education Program Supervisors (EPS) and School Heads are hereby directed to participate in a **face to face meeting** on September 9-10, 2020, 8:00-12:00 to 1:00-5:00, at the Ramon Magsaysay Central Elementary School.
- 2) The meeting aims to gather the LDM coaches and work on the finalization of their BE-LCP modules. The first four modules shall be taken up on the first day while the second day shall focus on the remaining three modules.
- 3) The finalized modules shall be emailed to the Schools Division Superintendent (Attn: Dr. Ida I. Juezan) on September 10, 2020. Hard copies shall also be submitted on the same day to the LAC leader for completeness, then to the Division Coach for final evaluation, who shall also make the submission to the Region on September 11, 2020 for validation by the Regional Coach.
- 4) Participants are advised to bring their own meal and snacks. Transportation expenses shall be charged to local//MOOE funds subject to the usual accounting and auditing procedures.
