2. The participants in this activity are Education Program Supervisor (EPS) for Kindergarten, Elementary School Head/Principal and all Kindergarten teachers. All participants shall join the designated FB Groups a week before the training commences on September 21, 2020, otherwise they shall not be accepted on the day of training.
3. The Division Kindergarten Coordinator is tasked to form a division team composed of: 1 Division Coordinator, 1 Elementary School Principal, and 1 Kindergarten teacher. The division team shall serve as facilitators in the selection and compilation of the materials as outputs by the teachers relative to the training topics. In this regard, only Regional Coordinator and division team shall attend the 5 –day training while School Principal and the teacher participants shall attend only up to the 4th day.

Furthermore, it is requested that the Division Kindergarten in collaboration with their Regional Kindergarten Coordinators shall form their Kindergarten division team composed of: 1 Division Coordinator, 1 SH/Principal, and 1 Kindergarten teacher. The division team shall serve as facilitators in the selection and compilation of the materials as outputs by the teachers relative to the training topics. In this regard, only the Regional Coordinator and division team shall attend the 5-day training while the SH/Principal and teacher-participants shall attend the 4-day training.
