

In line with the issuance of OUA Memo 00-0820-0067 dated August 12, 2020, releasing the list of **1st and 2nd Batches of Selected Teacher-Broadcasters** for DepEd TV, DepEd Radio, and DepEd Teleradyo that will take part on the implementation of the TV-Video/Radio-based Instruction (TV-Video/RBI) learning delivery modality, the following parameters and guidelines shall be observed and adopted in the engagement of said teacher-broadcasters:

A. Nature of Engagement and HR Procedural Guidelines

- 1. The qualified teaching personnel selected as Teacher-Broadcasters shall be engaged through reassignment¹ to DepEd Central Office Information Communication and Technology Service (CO-ICTS), in accordance with the Civil Service Commission (CSC) Omnibus Rules on Appointments and Other Human Resource Actions (ORAOHRA) and other applicable CSC rules and laws, such as Republic Act (R.A.) No. 4670 or the Magna Carta for Public School Teachers, and subject to the approval of the Schools Division Superintendent (SDS) as the Head of Office of the teacher's original station.
 - a. In processing the reassignment of qualified Teacher-Broadcasters, the concurrence of the SDS being the Head of Office in the original station shall be required based

on the list released by the Office of the Undersecretary for Administration. Succeeding batches of qualified teacher-broadcasters may be released, as necessary.

- b. Upon concurrence of the SDS, the appropriate reassignment papers (Special Order) shall be processed and facilitated by the Schools Division Office (SDO) concerned and approved by the SDS. Details of the reassignment paper shall include the following:
 - i. Name of personnel
 - ii. Original station
 - iii. Receiving office
 - iv. Place of Assignment
 - v. Duration of Reassignment
 - vi. Provision on the salary and benefits
 - vii. Provision on renewal of reassignment within one (1) year; and
 - viii. Other provision and/or instruction, as necessary/applicable.
- c. The salary and benefits of the reassigned teaching personnel shall still be drawn from the SDO where their plantilla item is lodged. Other miscellaneous expenses, such as travel, board and lodging (as needed), and communication expenses, shall be charged to the funds of CO-ICTS, subject to applicable accounting and auditing rules and regulations.
- 2. The overall supervision of the Teacher-Broadcasters reassigned to the CO-ICTS shall be under the Office of the Undersecretary for Administration (OUA), through the ICTS Office of the Director.
 - a. Being the receiving office and supervising authority, the CO-ICTS, through the OUA, shall coordinate with the SDOs, schools or community learning center (CLC), and personnel concerned, and release official issuances/communications on relevant instructions and detailed information to include those indicated in Part A, Item 1(b) of this Memorandum and other matters, such as but not limited to the following:
 - i. Terms of Reference or detailed Job Description
 - ii. Orientation and Training
 - iii. Operations and Implementation Details
 - iv. Work arrangements
 - v. Reporting mechanisms
 - vi. Collaboration and partnerships with other offices under Curriculum and Instruction in the Central, Regional and Schools Division Office

B. Effectivity/Duration of Engagement (Reassignment)

The reassignment of the Teacher-Broadcasters shall be six (6) months to one (1) year, depending on the specific engagement and function of each teacher-broadcaster. The CO-ICTS, through OUA, shall clearly communicate the exact period of engagement to the SDOs, school/CLC, and personnel concerned, subject to the approval of the SDS.

- a. The duration of reassignment of teacher-broadcasters shall be at least six (6) months. Extension of reassignment after the 6-month period may be allowed, subject to the approval of the SDS, **provided** that the total duration of the reassignment after such extension shall not exceed one (1) year pursuant to Section 13.a of the CSC ORAOHRA.
- b. In cases wherein the teacher-broadcaster has completed the preparation and recording of audio and video episodes prior to the expiration of their reassignment period as indicated in the Special Order, they may return to their original station through a return-to-post memorandum from CO-ICTS transmitted to the SDS.

C. Duties and Responsibilities of Teacher-Broadcasters

The teacher-broadcasters shall teach subjects before cameras and microphones for video and audio episodes which will be broadcasted nationwide DepEd TV, DepEd Radio, and DepEd Teleradyo. Specific duties and responsibilities of the Teacher-Broadcasters shall be guided by the OUA Memorandum No. 720-0053 and supplemental memorandum for issuance of OUA.

In light of the implementation of the Basic Education – Learning Continuity Plan (BE-LCP) starting SY 2020-2021, it is understood that the nature of work of the Teacher-Broadcasters **shall commensurate as regular teaching load**, as prescribed in RA No. 4670 or the *Magna Carta for Public School Teachers*, within the period of their reassignment.

D. Work Arrangement, Attendance, and Performance Monitoring

The work arrangement of reassigned personnel shall be set and agreed upon between the concerned teacher-broadcaster and the head of the CO-ICTS as the supervising authority, in accordance with DepEd Order (DO) No. 011, s. 2020 on the *Revised Guidelines on Alternative Work Arrangements in the Department of Education during the Period of State of National Emergency due to COVID-19 Pandemic*.

Subsequently, the provisions of the DO No. 011, s. 2020 under the performance monitoring and attendance mechanism shall apply. The teacher-broadcaster's performance targets and expected outputs for each week shall be agreed upon by the personnel concerned and the supervising

authority. The Individual Daily Log and Accomplishment Report shall be the basis of attendance and performance monitoring and assessment by the head of receiving office.

In cases when the teacher-broadcaster is required to report on-site or physically in any DepEd office (CO, RO, SDO), school or community learning center (CLC) in the performance of their duty, the teacher-broadcaster shall be considered part of skeleton workforce performing essential/critical services. Subsequently, such on-site/physical reporting shall subject to the applicable provisions of DO No. 11, s. 2020 and entitled to allowable compensation and benefits attached to it.

In view of travel restrictions due to existing community quarantine, the CO-ICTS may set-up production sites in DepEd field offices, schools, and CLCs, as may be necessary. Teacherbroadcasters may be assigned to physically report to these production sites, provided that the following parameters are observed:

- 1. There is proper coordination between and among CO-ICTS and the DepEd field office/school/CLC where the production site will be located. CO-ICTS shall facilitate the setting-up of the production site.
- 2. There is prior and proper coordination between and among CO-ICTS, the DepEd field office/school/CLC, and the teacher-broadcaster concerned on the attendance and performance monitoring.
- 3. Regular work in the DepEd field office/school/CLC is not in any case disrupted.
- 4. Stringent physical distancing and minumum public health and safety protocols are strictly observed.

E. Overtime Services, Leaves and Other Benefits

Considering that the functions to be performed by teacher-broadcasters are considered regular teaching load in accordance with Part C, Paragraph 2 of this Memorandum they shall be entitled to the usual remuneration and other benefits due to teachers, as may be applicable pursuant to existing laws, national policies, and DepEd issuances.

As such, allowable service credits shall be given to the teacher-broadcasters for their overtime 8-hour service rendered beyond the workday, performed in the DepEd CO/RO/SDO/school/CLC, subject to the provisions of DO No. 53, s. 2003 or the Updated DepEd Guidelines on Grant of Vacation Service Credits to Teachers, as well as other relevant and applicable accounting and auditing procedures. These service credits are exclusive of the 15 days maximum service credits allowed every year, subject to DO No. 16, s. 2009. For the purpose of determining the service credits, one-hour overtime work is equivalent to 1.25 hours. One service credit is granted for 6.4 hours of overtime service. A maximum of six (6) service credits may be earned per month.

Leave and/or absences during the duration of reassignment shall be charged against their accumulated service credits. Absences related to COVID-19 shall be covered by the provisions under item no. 32 of DO No. 11, s. 2020.

Remuneration and other benefits received by the teachers shall be maintained and granted to the reassigned teacher-broadcasters such as Cash Allowance, World Teacher's Day Incentive Benefit, COVID-19 Hazard Pay, etc., subject to the implementing guidelines set by the Department. Other miscellaneous expenses, such as travel, board and lodging (as necessary) and communication expenses, shall be charged to the funds of CO-ICTS, subject to accounting rules and regulations.

F. Other Guidelines

Teacher-broadcasters shall undergo extensive training and workshops with the media partners of DepEd from the month of August 2020 onwards. The participation of teacher-broadcasters in such training programs and workshops shall form part of their engagement, and therefore must be covered by the period of their respective reassignment.

The DepEd CO, through the OUA and CO-ICTS, shall ensure that the teacher-broadcasters are provided with the appropriate tools, supplies, and equipment to perform their agreed functions.

In the event that the teacher-broadcasters shall report onsite in DepEd CO, the ICTS shall arrange shuttle services or carpools for these personnel with strict health and physical distancing measures.

The receiving office shall provide protective garments and equipment to teacher-broadcasters and ensure the safety of these personnel pursuant to DO No. 14, s. 2020 *or the Guidelines on the Required Health Standards in Basic Education Offices and Schools.*

For monitoring purposes, the ICTS shall closely coordinate with the Bureau of Human Resource and Organizational Development – Personnel Division (BHROD-PD) on all documents related to the HR actions of the Teacher-Broadcasters.
