NURSES ON DUTY SCHEDULE IN THE IMPLEMENTATION OF HEALTH AND SAFETY PROTOCOL IN THE SCHOOLS DIVISION OFFICE

- 1. This is pursuant to DepED Order No. 014, s 2020 dated June 25, 2020 entitled Deped Required Health Standards based on DOH AO 2020 – 0015 or the Guidelines on the Risk Based Public Health Standards of COVID 19 Mitigation and EO 23 of Digos City.
- 2. To ensure that all personnel and visitors are following the minimum Health Standard such as washing of hands with soap, practice social distancing, temperature check, wearing of face mask and face shield and with 70% alcohol or sanitizers on hand at all times, the Division Nurses are instructed to perform their duties and responsibilities in the mitigation of COVID 19 such as to post as nurse on duty, to monitor, and to track health declaration forms of the employees, visitors, guests, clients or customers for contact tracing purposes. The Division Covid 19 Task Force must keep records and documents to be made available upon request by a government inspector or contact tracer.
