Pursuant to Department of Education Order No. 22, s.2015 issued on June 2, 2015 known as "Hiring Guidelines for the Remaining Teaching Positions x x x" you are hereby directed to convene and conduct reviews on the documents submitted by Teacher 1 applicants for the Secondary Grades for the specialization in **ENGLISH**, **FILIPINO**, **MATHEMATICS**, **SCIENCE** (**BIOLOGY**), **PHYSICAL EDUCATION** & **HEALTH**, **TLE** (**AGRI-FISHERY ARTS**), **TLE(HE)**, **EPP**, **AND ICT** who already applied for the initial round of hiring per D.O, No.7, s.2015. - 3. In view hereof, Teacher 1 applicants who shall submit documents for recalibration purposes are enjoined to submit their documents as soon as possible. The deadline for the submission of the additional documents shall be on November 6, 2020 (Friday-5:00pm) without extension.
